 - President Scout/Guides/Rover or Himalayan Wood Badge (HWP) holder certificate
 - Academic educational qualification certificates
 - Scouts & Guides qualification as mentioned in para 2 (b) of notification certificate
 - Candidate should furnish caste certificate from competent authorities as per the prescribed formats in the notification (for SC/ST/OBC- NCL (Non Creamy Layer for current financial Year i.e. issued on or after 01.04.2024), wherever applicable
 - Disability certificate, wherever applicable
 - Discharge certificate for Ex-servicemen and serving certificate of parent for children of Armed Forces Personnel, wherever applicable
 - "No Objection Certificate" from the employer, if already in service of PSU/Government Organizations.
- Please also note that no supplementary document verification shall be held
- Candidates are further advised to **check the website regularly henceforth for updates and link for downloading the call letter** for document verification.
- In case they fail to attend for Document Verification on the scheduled dates or unable to produce the required documents, their candidature will be cancelled. Candidate may have to stay for 2-3 days if necessary so they are advised to come prepared accordingly.
