5th Part Provisional Panel of Goods Guard under GDCE quota

125 vacancies of Goods Guard (UR-65, SC-17, ST-10, and OBC-33) were notified under GDCE Scheme vide RRC/CR's Notification No. RRC/CR/GDCE-01/2017 dated 01/12/2017.

Computer Based Test (CBT) of the eligible candidates was held by RRC/CR on 29/01/2019, 01/02/2019, 04/02/2019 & 08/02/2019 at BB, NGP, PA and JL.

First, Second, third & fourth part provisional panel were already published on this site on 24.06.2019, 11.09.2020, 21.10.2020 & 11.06.2021 respectively. The fifth part provisional panel of 02 candidates (1-OBC & 1- SC) is attached as Annexure-I.

The 5th Part provisional panel is purely provisional and appointment of candidates as Goods Guard will completely depend on fulfilling all other conditions like passing of requisite training, not undergoing any effective penalty, no SPE/Vig/DAR case is ongoing/pending/contemplated against them, fulfillment of other pre-recruitment formalities. Appearance of one's name in the part panel does not confer any right of appointment as Goods Guard.

Mere empanelment of candidates in the 5th Part Provisional Panel does not confer upon him/her any right to the post of Goods Guard. While due care has been taken in preparing the panel, RRC/CR/Mumbai reserves the right to make amendments to the provisionally declared panel at any subsequent stage of selection process. Besides, if any discrepancies/malpractices are noticed or brought to the notice of RRC/CR/Mumbai, then RRC/CR reserves rights to declare any candidate unsuccessful or delete his/her name from already published panel at any stage of selection process. The decision of Chairman/RRC in this regard shall be final.
