DECLARATION OF PROVISIONAL PANEL OF B2/C1 MEDICALLY FIT CANDIDATES

1. In terms of Railway Board's letter No. E(NG)II/2023/RR-1/63 dated 16.12.2024 & 10.06.2025, the Provisional panel of 77 (Seventy Seven) candidates who are medically fit in B2/C1 for recruitment in posts in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix against Centralized Employment Notice No. RRC - 01/2019 on Central Railway is issued with the approval of the Competent Authority. The list of such candidates is attached herewith in ascending order of Roll numbers. This panel is purely provisional and does not give any right to any candidate for job in Railways. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
2. The Computer Based Test (CBT) was conducted during the period 17/08/2022 to 11/10/2022 by Railway Recruitment Boards (RRBs). Physical Efficiency Test(PET) has been conducted from 16/01/2023 to 21/01/2023 at Nagpur and Solapur. The 1st stage of Document Verification was conducted from 16/02/2023 to 11/03/2023 and for absent candidates / pending cases on 30.03.2023, 31.03.2023 & 03.04.2023. The 2nd stage of Document Verification was conducted on 31.08.2023 and 01.09.2023 and the supplementary document verification for absent candidates was conducted on 12.09.2023. The 3rd stage of Document Verification was conducted on 01.11.2023 and 02.11.2023 and the supplementary document verification for absent candidates was conducted on 23.11.2023. The 4th stage Document Verification was conducted on 09.01.2024, 10.01.2024 and 11.01.2024 and the supplementary document verification for absent candidates was conducted on 24.01.2024. The 5th stage Document Verification was conducted on 28.02.2024, and 01.03.2024 and the supplementary document verification for absent candidates was conducted on 14.03.2024. The 6th stage Document Verification was conducted on 21.05.2024 and 22.05.2024 and the supplementary document verification for absent candidates was conducted on 30.05.2024. The 7th phase of document verification was conducted on 11.07.2024 to 12.07.2024 and 15.07.2024 to 19.07.2024 & Supplementary document verification for absent/pending candidates was conducted on 29.07.2024. Candidates were sent for medical examination at Byculla / Kalyan / Bhusawal/ Nagpur / Pune / Solapur Railway hospitals after the Document Verification.
3. The panel is prepared on the basis of overall rank in Computer Based Test (CBT) and fitness in medial categories for recruitment in posts in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix. The seniority of the candidates selected will be decided later as per the merit position in the Panel which will be declared at a later stage.
4. Allotment of posts and divisions will be made available on RRC/CR/WB website within two days.
5. While due care has been taken in preparing the result, RRC/Central Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC/CR at any stage, RRC/CR reserves the right to rectify any inadvertent error or Typographical/Printing mistakes and declares any candidate unsuccessful or deletes the name of candidate from the notified panel at any stage. The decision of Chairman, RRC in the matter shall be final and binding on the candidate.
6. The offer of appointment shall be sent separately by the respective units/divisions where the candidates are allotted. The offer of appointment will be issued after verification as per extent rules.
