DECLARATION OF PROVISIONAL PANEL OF B2/C1 MEDICALLY FIT CANDIDATES: PART - 03

1. In terms of Railway Board's letter No. E(NG)II/2023/RR-1/63 dated 16.12.2024 & 10.06.2025, the Provisional panel of 25 (Twenty five) candidates who are medically fit in B2/C1 for recruitment in post in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix against Centralized Employment Notice No. RRC - 01/2019 on Central Railway, as mentioned below in ascending order of Roll numbers, is hereby declared with the approval of the Competent Authority. This panel is purely provisional and does not give any right to any candidate for job in Railways. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
2. These 25 B2/C1 medically fit candidates who could neither be accommodated on Central Railway nor could be diverted to other Railway for want of vacancies under CEN 1/2019, have now been accommodated on Central Railway in terms of Railway Board's instructions vide letter dated 20.03.2026 by readjustment of vacancies of higher medical standard posts to lower medical standard posts. These vacancies have been received consequent upon seeking replacement vacancies after diversion of the panel to other Railways.
3. The Computer Based Test (CBT) was conducted from 17.08.2022 to 11.10.2022 by RRBs. A total of 7 stages of Document Verification (DV) and 3 phases of replacement DV were conducted from Feb. 2023 to Nov. 2024, including supplementary DVs for absent/pending candidates. Candidates were subsequently sent for medical examination at Railway hospitals (Byculla, Kalyan, Bhusawal, Nagpur, Pune, and Solapur).
4. The panel is prepared on the basis of overall rank in Computer Based Test (CBT) and fitness in medical categories for recruitment in post in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix. The seniority of the candidates selected will be decided later as per the merit position in the Panel which will be declared at a later stage.
5. Allotment of post and division/unit will be made available on RRC/CR/WB website within next few days.
6. While due care has been taken in preparing the result, RRC/Central Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC/CR at any stage, RRC/CR reserves the right to rectify any inadvertent error or Typographical/Printing mistakes and declares any candidate unsuccessful or delete the name of candidate from the notified panel at any stage. The decision of Chairman, RRC in the matter shall be final and binding on the candidate.
7. The offer of appointment shall be sent separately by the respective units/division where the candidates are allotted. The offer of appointment will be issued after verification as per extent rules.
